Contest Rules and Regulations

1. Contest is for Fox, Coyotes, and Bobcats.
2. Contest is based on a point system; **Fox = 1 point apiece, Coyotes = 2 points apiece, and Bobcats = 4 points apiece.** The team with the highest number of points at the end of the contest wins.
3. Contest begins Saturday and ends Sunday.
4. Entry fee is \$100.00 per team (two members per team maximum), plus 7% sales tax.
5. 25-team limit (All entries are on a first come, first served basis).
6. Permits will be issued by Acoma Game and Fish Enterprise after the completion of the orientation meeting.
7. All hunters must have in their possession at all times a valid Pueblo of Acoma hunting permit. All tribal hunting regulations will be adhered to.
8. Cash prizes will be awarded to first, second and third place teams. (Prize amounts will be determined on the number of entries).
9. Legal firearms: .204 - .25 caliber center-fire rifles, shotguns no smaller than 20 gauge - including semi-automatic weapons.
10. Electronic and handheld calls may be used.
11. Use of any type of bait is prohibited.
12. Hunters must hunt together at each setup. **NO ATV'S/UTV'S ALLOWED.**
13. Hunters may use artificial decoys; use of live animals is prohibited.
14. Video filming is prohibited.
15. No night hunting is allowed. Hunt hours will be from ½ hour before sunrise to sunset on Saturday. Sunday hunt runs from ½ hour before sunrise to 3:00 PM.
16. Preliminary Check-in of animals will be conducted at Game and Fish Headquarters on Saturday @ 6:00 PM. The final check-in will be held on Sunday @ 3:00 PM. Hunters are required to check-in both days regardless of number of animals harvested.
17. The clock at Game and Fish Headquarters is the official clock. In the event of a tie the team who checks in first wins.
18. Only the entire carcass will be accepted. Carcasses will be brought to the Game and Fish Office at Acomita Lake. All carcasses will be inspected.
19. Bobcat and Fox pelts and skulls remain property of Acoma Pueblo.
20. Any team in violation of the above rules and regulations will be immediately disqualified and banned from all further Predator Contests on Acoma Pueblo.

Waiver

The Pueblo of Acoma, Acoma Business Enterprises and Game and Fish Enterprise, its officers and agents are not responsible for injuries, accidents, deaths, theft, fire, or acts of nature which occur while participating in this predator calling contest.

By executing and submitting the Notification herein, the applicant hereby waives and releases the Pueblo of Acoma, its agents and employees, and agrees to indemnify and hold the Tribe harmless from any liability for damages to persons or property, whether foreseeable or unforeseeable, resulting from or incurred during the course of participation in this predator calling contest on the Pueblo of Acoma.
